- Payment.** Credit Card Authorization form, Certified Check, or Money Order payable to VisaHQ.ca.
- Return mailer.** Prepaid self-addressed return label or payment for FedEx.

Letter of Invitation. An original letter of invitation approved by the Ministry of Foreign Affairs in Turkey.

- Business Letter.** A business letter from either the sending company in Canada or sponsoring company in Turkey, on their letterhead stationary, addressed to The Embassy of Turkey, and signed by a senior manager (an equivalent to Vice-President or above), briefly introducing the applicant (please specify employment status/position held in the company by applicant) and clearly stating the precise nature of the business to be conducted by applicant. If requesting a multiple entry visa, the letter should specifically request the multiple entry visa and explain why the applicant will be traveling to Turkey so often.

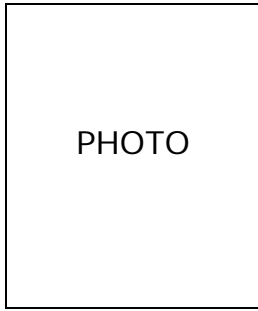
